- 7) All vendors must vacate the fairgrounds as soon as possible following the close of the Fair and must be removed by 11 a.m. on Sunday, August 8, 2021. Failure to adhere to this will jeopardize your acceptance at future Fairs.
- 8) No animals are permitted on the fairgrounds by the vendors. Exhibitors must wear proper attire (shirts/shoes) at all times even when setting up and breaking down.
- 9) **HOLD HARMLESS AND RELEASE CLAUSE: THE VENDOR HEREBY RELEASES AND DISCHARGES THE ATLANTIC COUNTY 4-H FAIR ASSOCIATION AND ITS VOLUNTEERS FROM ANY AND ALL RESPONSIBILITY OR LIABILITY FOR INJURY OR DAMAGE TO ANY OF THE APPROVED EXHIBITS AND ALSO RELEASES AND AGREES TO INDEMNIFY THE ATLANTIC COUNTY 4-H FAIR ASSOCIATION AND ITS VOLUNTEERS AGAINST ANY DAMAGE, CLAIM, LEGAL PROCEEDING, OR JUDGEMENT ARISING OUT OF TRANSPORTATION, ENTRY, EXHIBITION OF THE APPROVED EXHIBITS AT THE SAID 4-H FAIR FROM ANY PERSONAL INJURY SUSTAINED BY THE EXHIBITOR, HIS AGENTS, SERVANTS, EMPLOYEES, LICENSEES, OR GUESTS BY REASON OF ANY CAUSE WHATSOEVER AND ANY OTHER RULES AS MAY BE NECESSARY.**
- 10) The fee for your vendor space includes electricity. This electrical fee includes general lighting and use of ONE outlet, 1000 watts, 10 amps (110V). If you require more than one receptacle, additional service can be provided (where available) for a \$10 fee for each 500 watts. Extension cords are the responsibility of the vendor. All electrical equipment must be heavy duty and properly grounded. No generators permitted. Momentary or intermittent power uses such as compressors, heat presses, etc. is considered "USE" and will be charged accordingly. Signing of this contract agrees to the above rates and the metering of use by the 4-H Fair Association electrical manager.
- 11) Possession and/or use of alcoholic beverages or drugs are FORBIDDEN on the property of the David C. Wood 4-H Center and Fairgrounds.
- 12) The 4-H Fair Association is NOT responsible for furnishing tables, chairs, canopies, umbrellas, or materials other than space. All are the responsibility of the vendor.
- 13) The 4-H Fair Association will not be responsible for exhibitors against fire, accident, or any other cause. If an exhibitor desires any insurance coverage relating to exhibit or persons concerned there at, they must obtain such coverage at their own expense.
- 14) SUBLETTING OF SPACE PROHIBITED. Anyone found in violation of this will be asked to leave the fairgrounds with no refund and will result in forfeiture of the right to exhibit in future 4-H Fairs.
